SICF Administers Grants from the 2020 Census, the Illinois State Trust, Marion United, and Southern Illinois Strong

Though we have been practicing social distancing, it's been a very busy season in the SICF office. We started the spring off preparing to administer grant funds promoting the 2020 Census. Soon thereafter, the COVID-19 pandemic began to sweep across the country and shelter-in-place practices were announced by our governor. Many events planned to promote the census then went online or were otherwise recalibrated. Priorities shifted radically to help support individuals, families, and businesses struggling to stay afloat after businesses and schools were closed.

To meet these new priorities, there were two rounds of state funding for a program called the Illinois COVID-19 Response Fund specifically for agencies providing food and shelter to needy individuals and families. The second round direct service providers in healthcare and child safety. CEO Byram Fager and Program Associate Cynthia Roth worked with Toni Hayden of the United Way of Southern Illinois in granting these funds. We also received assistance from Toni Kay Wright of the University of Illinois Extension and Angie Bailey of SIH. 53 organizations throughout Southern Illinois received grants to meet the growing needs in our region during this pandemic.

While that was happening, two businessmen in Marion, IL, Josh Benitone and Jared Gravatt, organized a livestream event to benefit local small businesses in Marion. The event called [Marion United](#) raised nearly \$200,000! 111 Marion businesses applied for grants from Marion United and received funds. This was truly an amazing happening for a small town and a great example of people helping one another get through a difficult time.

Then came [Southern Illinois Strong](#), was a grant program and T-shirt campaign presented and organized by State Representatives Terri Bryant, Nathan Reitz, Dave Severin, Patrick Windhorst, and State Senators Dale Fowler and Paul Schimpf in conjunction with the Southern Illinois Community Foundation to support brick and mortar businesses in Southern Illinois. Eighteen businesses received grants by drawing in this campaign.

Scholarships Awarded

Six college scholarship awards were given out in virtual ceremonies to college-bound Southern Illinois high school students in May.

Richard Bartolotti Scholarship was awarded to **Gillian Lemons** of Sesser, IL. Gillian attended Sesser-Valier High School and is heading to the St. Louis School of Pharmacy in the fall.

Merwin and Villa Spenser Scholarship winner is **Grace Barlage** of Murphysboro, IL. Grace attended Murphysboro High School and is heading to Southeast Missouri State University to study animal science.

Tim Herring Scholarship was presented to **Aren Abell**. Aren attended Murphysboro High School and will be studying physiology at Southern Illinois University Carbondale in the fall with the goal of becoming a physician.

George and Goldie Mae Hall Scholarship is **Dillon Banach** of Waltonville High School. Dillon will be attending Rend Lake College in the fall.

Tom Mygatt Scholarship was awarded to **Adyson Erwin** of Sesser-Valier High School, who will attend Southern Illinois University Carbondale this fall and major in Dental Hygiene.

Cliff Stein Scholarship recipient is Murphysboro High School student **Jamarr McZeke**, a basketball standout who is attending college with the goal of becoming an eye doctor.

Wellman and Adeline Kerr Scholarships were won by **Jessie Lewis** and **Kaylee Fraser**.

Massac County Academic Award Scholarships were won by **Gracie Stewart, Owen Westbrooks, Dawson Troutman, Madalynn Coakley, Jessie Lewis, Kaylee Fraser, Kalissa Cox, and Anna Thompson.**

The event was the creation of two local businessmen: Josh Benitone and Jared Gravatt, who devised this event and made it happen while they were busy starting their own new business in Marion, Crown Brew Coffee Co. But they put that important work aside in the midst of the COVID-19 pandemic when they realized the established businesses in their city were suffering and struggling. In their own words: “There is an amazing opportunity for the citizens, churches, businesses, and organizations to UNITE and help them through this. MARION UNITED is a collaborative effort to generate grants for local businesses affected by the COVID-19 pandemic.”

As the COVID-19 crisis has caused economic hardship to businesses in Southern Illinois and throughout the country, the Southern Illinois state legislative delegation got together in a bipartisan effort to endorse the **Southern Illinois Strong** T-shirt fundraising drive. State Senator Dale Fowler (R-Harrisburg) and State Senator Paul Schimpf (R-Waterloo) joined with State Rep. Terri Bryant, State Rep. Dave Severin, State Rep. Patrick Windhorst, and State Rep. Nathan Reitz to promote and support this campaign.

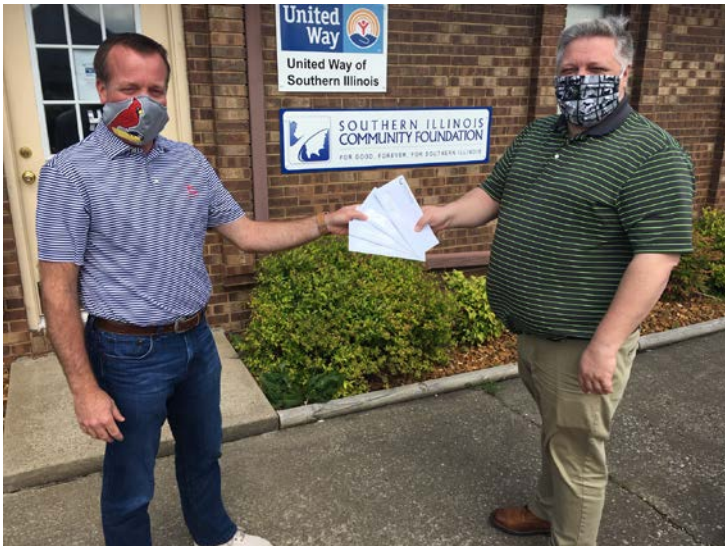
This bipartisan delegation of legislators supported **Southern Illinois Strong** by sharing information on their respective Facebook pages to raise awareness. Funds raised from T-shirt sales were deposited into an account managed by the Southern Illinois Community Foundation (SICF). Grants were awarded in May to small businesses impacted by the coronavirus outbreak and were awarded by SICF via lottery. Eligible businesses had 25 or fewer employees. The **Southern Illinois Strong** fundraiser ran from Thursday, April 16 through Wednesday, May 6.

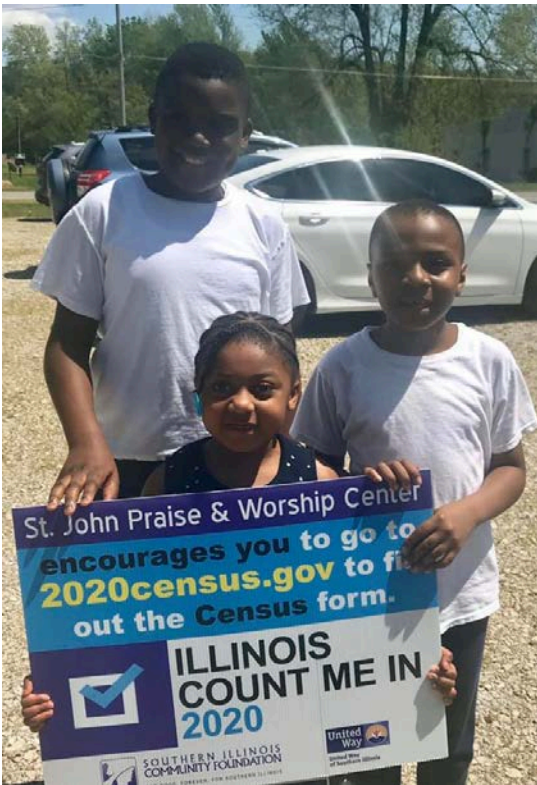

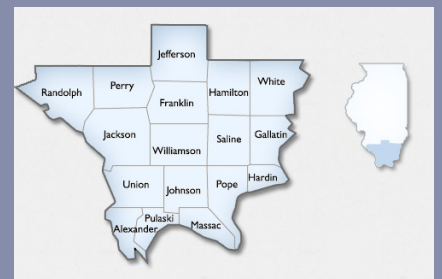
